2rd Plenary Meeting Chiang Mai, Thailand July 26 - 27, 1996

Introductory Remark

Presently, ASEA - UNINET is composed of 6 Austria, 6 Vietnamese, 3 Indonesian and 10 Thai univerities.

Summary of the Meeting

The national coordinator for Indonesia, Professor Soekanto Reksohadiprodjo, Rector, Indonesia will act as ASEA - UNINET chairman for intersessional period. Dr. Surapone Virulrak, Vice-President for Planning and Development, Chulalongkorn University, was nominated as national coordinator for Thailand.

During the intersessional periods, working groups can be established and meet for the preparation of the agenda.

Regarding contact with UNESCO, Dr.Rode will arrange for a meeting with a high ranking UNESCO officials in Paris in order to negotiate terms and conditions of relationship between ASEA UNINET and UNESCO.

Dr Wang Yibing has offered to provide financial support for some aspects of organizing costs for ASEA - UNINET activities to be negotiated and fare for members in need of financial assistance.

Conference participants broke into 3 groups according to the following themes of group discussion :

- I Administration
- II Academic cooperation in Agriculture/Biology
- III Academic cooperation in Tourism/Engineering

 - 2. This meeting will take place in February, 1998.
- 3. The next chairman of the intersessional meeting is Professor Soekanto Reksohadiprodjo

- 4. The meeting agreed to modify the M.O.U. so as to receive new members.
- 5. New members will pay an enrollment fee of \$500.
- 6. A Membership fee for a European university and a Southeast Asian university is \$1000 and \$500 respectively.
- 7. The meeting representatives of UNESCO and RIHED are willing to contribute financially to the organisation of the 3^{rd} Plenary Meeting.
- 8. ASEA-UNINET is to negotiate terms of this financial contribution with UNESCO and RIHED.
- 9. National coordinators of each country will propose suitable candidates for new membership.
- 10. New members will have a status of associate member. Whether associate members will obtain a full membership status will be deliberated at the next Plenary Meeting on the basis of their commitment to ASEA-UNINET.
